OFFICE MEMORANDUM

The Swachh Bharat Mission (Urban) has the following components to be implemented before 02.10.2019 for achieving total sanitation as a tribute to the Father of Nation, Mahatma Gandhi.

The components to be implemented and the funding arrangements are as follows:

Component No	Component	Central Contribution	State Contribution
I	Household Toilets	Rs. 4000/-	Minimum 25% funds to match Central Share (Ratio of 75:25).  In case of North-East States and Special Category States the ratio is 90:10.
II	Community Toilets	40%	
III	Public Toilets	Nil	-
IV	Solid Waste Management	20%	Minimum 25% funds to match Central Share (Ratio of 75:25).
V	IEC and Public Awareness	As per Guidelines	In case of North-East States and Special Category States the ratio is 90:10.
VI	Capacity Building and Administrative & Office Expenses	As per Guidelines	

3. However, in order to further incentivise and fast track the implementation of Swachh Bharat Mission Urban, several State Governments have committed higher funding than the guidelines. For example, Government of Gujarat have committed Rs. 12000/- funding to Household toilets and Government of Telangana Rs. 8000/- Such increased contribution will undoubtedly assist the ULBs in achieving 100% sanitation.

4. As the matter SBM implementation is frequently raised in the Parliament, it is requested to furnish information on the commitment of State Government assistance to the Swachh Bharat Mission components over and above the SBM Guidelines.

5. The information may kindly be furnished by return fax as the Starred Question on Swachh Bharat Mission Urban is due in the Parliament on 29.04.2015.
